2025.46 Ward Councillors' Reports

- Two parts of the footpath along Town Street had been noted, one where a hedge is in need of cutting back to create space and one where the kerb is crumbling
- A new initiative has launched to control litter in areas where littering is an ongoing problem. This will be carried out by a third party company with a revenue sharing arrangement
- The Local Waste Strategy is approaching renewal and a number of options are being considered including a Deposit Return Scheme at local shops

Cllr C. Bird asked Ward Cllr West for an update on the Mayor of the Hull and East Yorkshire Combined Authority who had been elected on 1st May 2025

- Cllr Halkon noted an area of crumbling concrete along Church Lane
ACTION: Ward Cllr West to report this to ERYC Streetscene
Cllr Halkon also noted the recent amendment to the Planning Application at Kilnwick Percy Resort & Golf Club which reduces the proposed number of new lodges from 30 to 28
- Cllr Richardson advised that he will follow up on the water sampling of The Beck, and that the foliage growth in Jubilee Wood will be checked
- Cllrs C. Bird and R. Bird asked whether a small area of verge could be removed on Millington Lane. The location is <https://what3words.com/walked.alienated.petulant>
ACTION: Ward Cllr West to enquire about verge hardening for that area of verge
- Cllr R. Bird noted that ERYC had been checking salt bins in the area early this year
- Cllr C. Bird advised that rogue works had been calling on local households and that people should remain vigilant


