- Repairs have been made on the road between Nunburnholme and Burnby, with the work being completed to a good standard
- The [Fair Funding Review 2.0](#) is expected to negatively impact ERYC's budget through changes to funding for Councils in more rural areas and a change in the percentage of business rates which are retained by local authorities. As a result, Council Tax is likely to be increase by the full 5% each year for the foreseeable future.
